Subsea survey work's lasting approximately 5 days will be carried out on the Beatrice Offshore Windfarm between the 23rd and 30th June 2023, weather permitting. The surveys will take place around both Offshore Transmission Modules (OTM1 and OTM2) additional seabed survey's will be carried out at M09, D08, F13 and J10 which will comprise both a Seabed suitability survey (multibeam and SSS) and a UXO survey (magnetometer). The survey will be conducted by one unmanned vessel, X-06, details in section 3.




Figure 2- Survey Area around OTM's and WTG's


