1. Area of Planned Activity

Subsea survey work's lasting approximately 5 days will be carried out on the Beatrice Offshore Windfarm between the 12th and 20th June 2023, weather permitting. The surveys will take place around both Offshore Transmission Modules (OTM1 and OTM2) and will comprise both a Seabed suitability survey (multibeam and SSS) and a UXO survey (magnetometer).

The survey will be conducted by one unmanned vessel, namely X-06 or X-15, details in section 3. Only one of these vessels will be utilised to be confirmed.

Figure 1- OTM Locations – Marked with Red Dot.

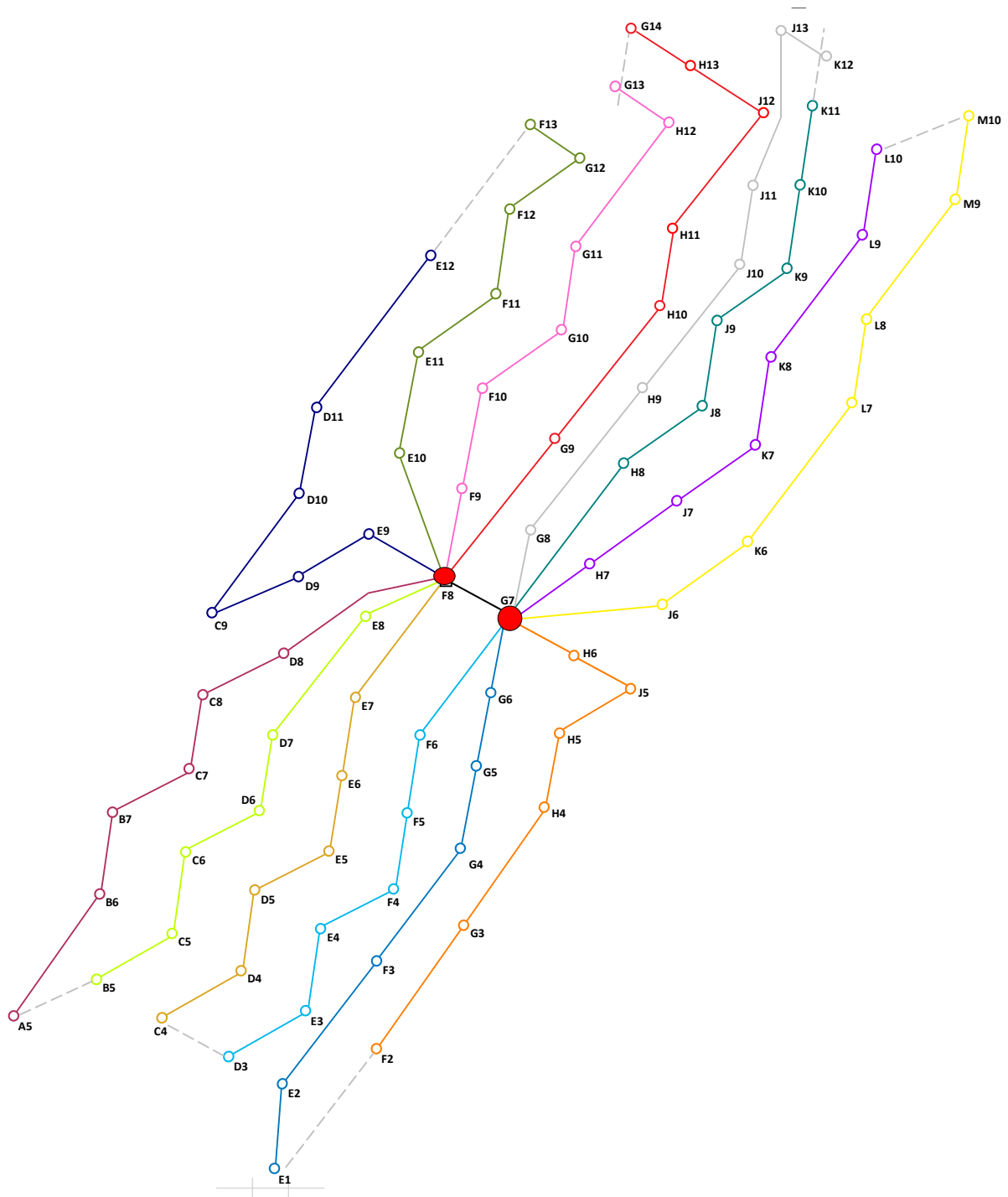


Figure 2- Survey Area around OTM's.

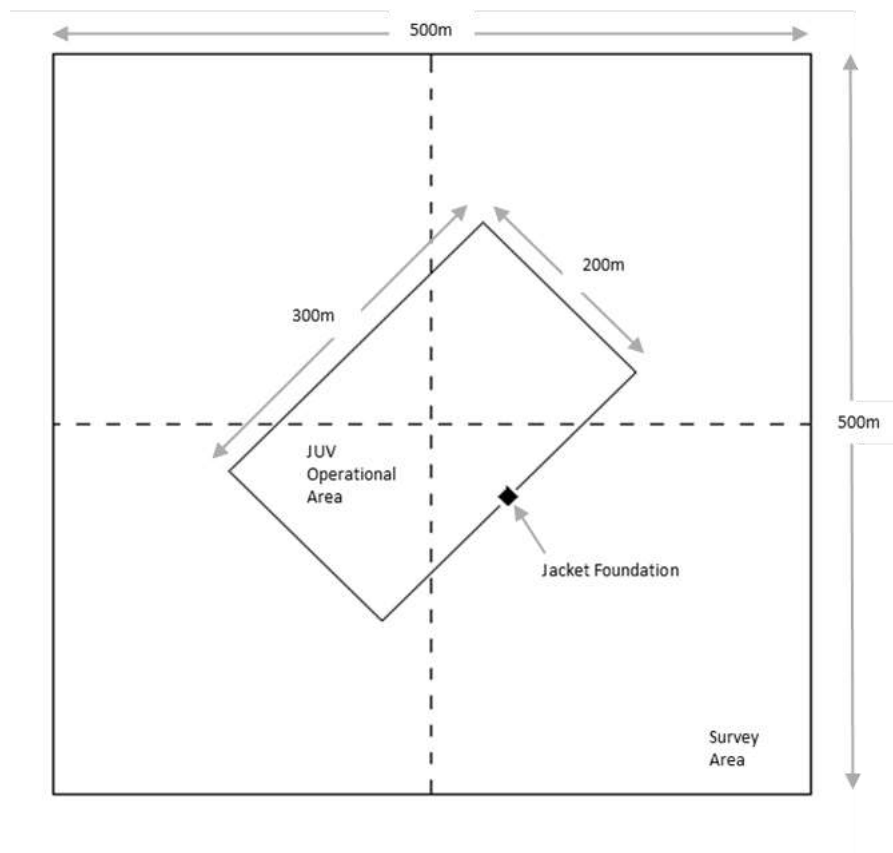
